SELECTION CRITERIA

CARH's **State Affiliated Association of the Year Award** is designed to recognize and encourage excellence in the programs, services, and management of CARH's state affiliated associations. This state affiliate award joins CARH's awards program in highlighting the high standards of the rural affordable housing industry.

ELIGIBILITY

All CARH state affiliated associations in good standing are eligible for consideration.

CRITERIA

In judging the application, the full scope of a state affiliated association's function will be taken into consideration. Areas to be considered for the Award include:

- Contributions and Service to the Community and to the Industry
 - Raising Public Awareness of the Affordable Rural Housing Industry by Undertaking Positive Initiatives
- Government and Legislative Affairs Involvement
- Membership Growth and Retention
- Education and Training Opportunities
- Programming
 - Meeting Planning, Networking, and Social Events
- Communication
 - Within the State Membership, as well as with the National CARH Office
 - Communication Examples: Newsletters; Association Website; Membership Directory; Surveys; Publications; Social Media
- Fostering Productive Working Relationship Between Industry and Local & State Regulating Agencies
- Leadership and Professional Development (for Executive Director and Board of Directors)
- Effective Management

JUDGING

Applications for CARH's State Affiliated Association of the Year Award will be considered by the Awards Committee, with the input of the CARH National Office staff. All nominees are encouraged to present a summary of their accomplishments during the State Affiliated Associations Committee Meeting at the 2019 Midyear Meeting.

SUBMISSION

Submit a synopsis of association activities, accomplishments, and any supporting materials to the CARH National Office. The application may focus on any or all of the above criteria. Submissions must be received by **December 28, 2018**.

The affiliates selected to receive this prestigious award will be honored during the Awards event during CARH's 2019 Midyear Meeting. In addition, a plaque recognizing all recipients of the State Affiliated Association of the Year Award is on display in CARH's national headquarters.
