### About the CARH Scholarship Foundation

The CARH Scholarship Foundation awards scholarships annually to deserving exceptional students from rural affordable housing across the United States. The foundation was created in 2005 to promote education and expand opportunities for residents of CARH-member properties. It has grown from awarding two scholarships in 2006 to six scholarships in 2020.

The first two scholarships were named in honor of James L. Poehlman of T&C Associates of Middleton, WI, and Gordon L. Blackwell of GLB Associates of Raleigh, NC. Mr. Poehlman was a founding member of CARH, a board member, Chair of the Owner and Development Committee, Co-Chair for the Aging Portfolio Committee, an Advisory Trustee, and 1998 Member of the Year, before his death in 2004. Mr. Blackwell was a longtime CARH member and former board member. He was also the founder, President, and Chairman of the Regency Housing Group, the largest developer of affordable rental apartments in the United States in 2001. He died in 2006.

The foundation honored Jack Godin, Jr. at his death in 2010 by naming a third scholarship in his memory. Mr. Godin was a founding CARH member and past president, and Vice President of

the Southern Development Company, which built, managed, and owned hundreds of affordable housing complexes in rural and urban areas throughout Alabama.

The CRHD Founders Scholarship was added in 2013, honoring the founders of the Council for Rural Housing and Development, the precursor to CARH. The fifth scholarship is named the CARH Scholarship Foundation Scholarship and was added in 2015. The sixth scholarship was added in 2020 and honors the Council for Affordable and Rural Housing. All six scholarships provide \$1,500 each semester for up to four years of undergraduate studies or vocational training.

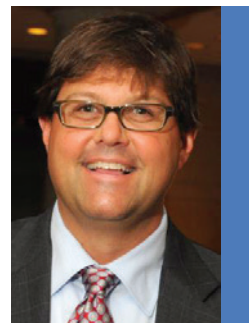

## Meet Jilliana Grace Boyd of Albertville, Alabama – 2016 CARH Scholarship Recipient

*Resident of Angela Meadows, Albertville, Alabama. Managed by Olympia Management.*



Jilliana Boyd, or Jilli as everyone calls her, has earned two degrees, embarked on a third, and worked on the front lines of the COVID-19 pandemic since she was named the recipient of the Jack Godin, Jr. Scholarship in 2016. After graduating from Albertville High School that year, she postponed her dream of attending a four-year university, and started classes at Snead State Community College just ten days after graduation. Jilli's mother had recently enrolled at the community college to complete her unfinished studies and was also newly diagnosed with cancer. She wanted to be there for her mom. Just one year later, Jilli earned her Associate's Degree with a 4.0 grade point average. She and her mom walked together at graduation.

With her mom doing better, Jilli went back to her original plan and entered The University of Alabama (UA) in Tuscaloosa where she earned her second degree, a Bachelor of Arts in Communication and Information Sciences in August 2020. But prior to graduating, Jilli decided she wanted a career in nursing and entered nursing school at The University of Alabama at Birmingham (UAB) during her last semester at UA. Jilli will graduate with a Bachelor of Science in Nursing in August 2021. She'll start UAB's Doctorate of Nursing Practice program immediately after graduation to become a Family Nurse Practitioner. Jilli will also work full time throughout the Doctorate program in the UAB Emergency Department. Upon graduation, she plans to work in rural healthcare. According to Jilli, "I grew up in a rural community, worked like crazy to make it out, and want to help provide others with the resources to live a healthier life and make the most of what they are capable of achieving."

Jilli achieved her dream of obtaining a four-year college degree and entered nursing school as she faced the many challenges brought on by the COVID-19 pandemic. In early 2020 while completing her studies for her UA degree, Jilli was simultaneously obtaining clinical experience at The UAB Hospital. Once the pandemic hit, all in-person clinical experience ended and moved to Zoom as did her classes. Her greatest fear was not graduating on time. As schools

shut down, she had to move in with her mother. While she didn't have to worry about how to pay for gas to commute to school, she did have to worry about internet access as there was none at home. Jilli had to sit at a neighbor's house or in the parking lot of businesses with WiFi to attend classes, take exams, and complete assignments. She lost two of her three jobs. Her mom lost all of hers. They took turns paying for groceries.

Despite the obstacles created by the pandemic, Jilli continued to find a way around them and thrive. By December 2020, she was asked to join a UAB team of faculty and students who were quickly trained to relieve exhausted nurses working in the COVID Intensive Care Units. The team was also trained to work COVID-19 vaccination sites in parking decks and auditoriums in the Greater Birmingham area administering some of the first vaccines in the United States.

There is no doubt that Jilli has accomplished so much through hard work, determination and her abilities, but she is quick to give credit to her CARH scholarship as well.

According to Jilli, "The CARH scholarship meant more to me than covering the cost of classes and books. It was motivation to keep pushing through the difficult nights of studying because the donors and CARH believed in my abilities and wanted me to strive for greatness.

Without the CARH scholarship, I know for a fact I would be sitting on debt. Instead, I have broken the line of poverty in my family. I graduated with an Associate's degree and a Bachelor's degree. I'll have a Nursing degree as well. And because the CARH scholarship allowed me the opportunity to attend one of the most well-known medical universities in the U.S., I have guaranteed my doctorate degree will be paid in full as well. I have less stress and feel mentally and emotionally healthier. To be debt-free is an amazing feeling coming out of college!"

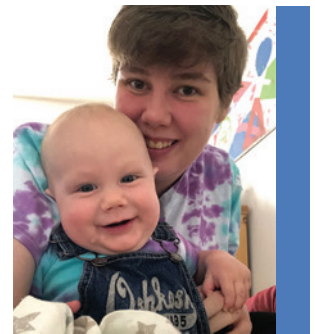
**Wesley Partch** received his scholarship while a resident of Lake City Apartments in Lake City, Pennsylvania, a property managed by TM Associates Management.

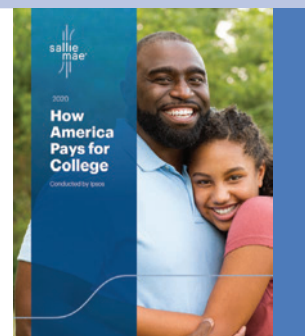

Dear Friends,


